Several members of the current Board will not be running for reelection in 2025/2026 due to the many years they have volunteered as members of the Spring Breeze Board.



Spring Breeze Community Rules



MD Lawn Fertilizer Law

To prevent runoff, fertilizer should only be applied to lawns when the grass is actively growing.

Fertilize cool-season grasses (fescues, bluegrass) in fall, based on soil test results.

Do not exceed 0.9 pound total nitrogen per 1,000 square feet and 0.7 pound of soluble nitrogen per 1,000 square feet for a single application.

A soil test is required before phosphorus may be applied to established lawns. Scan here for soil testing

Do not apply lawn fertilizer between **November 16 and March 1**.

Remember, do not apply fertilizer to lawns if heavy rain is expected.

TRASH PROBLEMS: -continued

King Contrivance Covenants Section 8.06 states.

"No lumber, metals, bulk materials, refuse or trash shall be kept, stored, or allowed to accumulate on any Lot...If trash or other refuse is to be disposed of by being picked up and carried away on a regular and recurring basis, containers may be placed in the open, on any day that a pickup is to be made, at such place on the Lot so as to provide access to persons making such pickup.

At all other times such containers shall be stored in such a manner so that they cannot be seen from adjacent and surrounding property."
